- 1) I am assuming LG-D-18D refers to the new door to the manifold position on lower ground – this should be suited as a 'Sub M2 Riser' key
- 2) Door 00-D-8B - If this has a cylinder then it should be suited as 'Sub M2 Riser' key
- 3) Door 00-D-8C – please confirm where this is as it is not on my drawing
- 4) Door 04-D-7B - please confirm where this is as it is not on my drawing
- 5) Door B1-D-60A – should be suited as 'Sub M1 Plant' key – door and hardware is supply by metal door company – speak to francis
- 6) *General – Package references need to be added where missing – what does this mean?*
