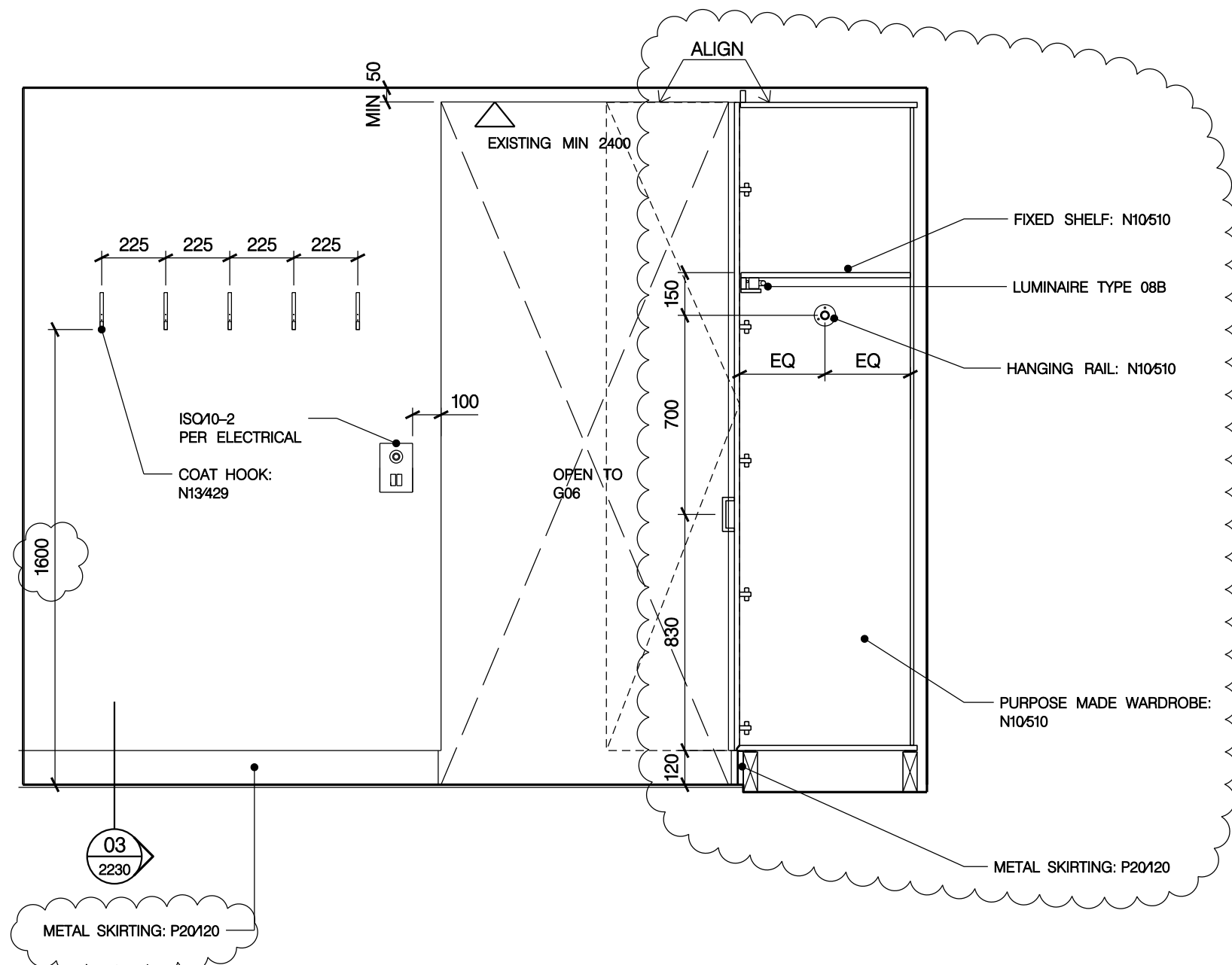
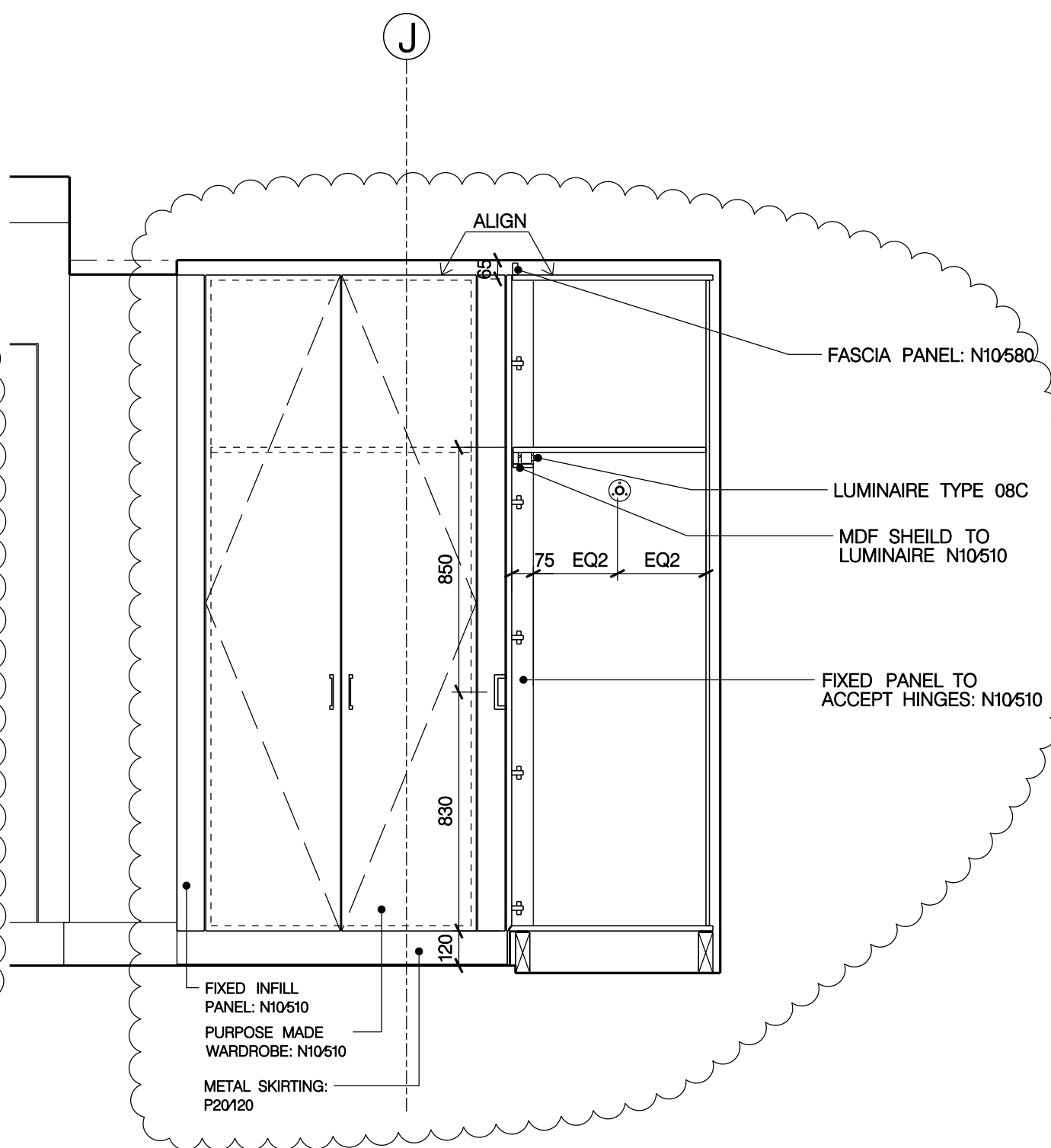


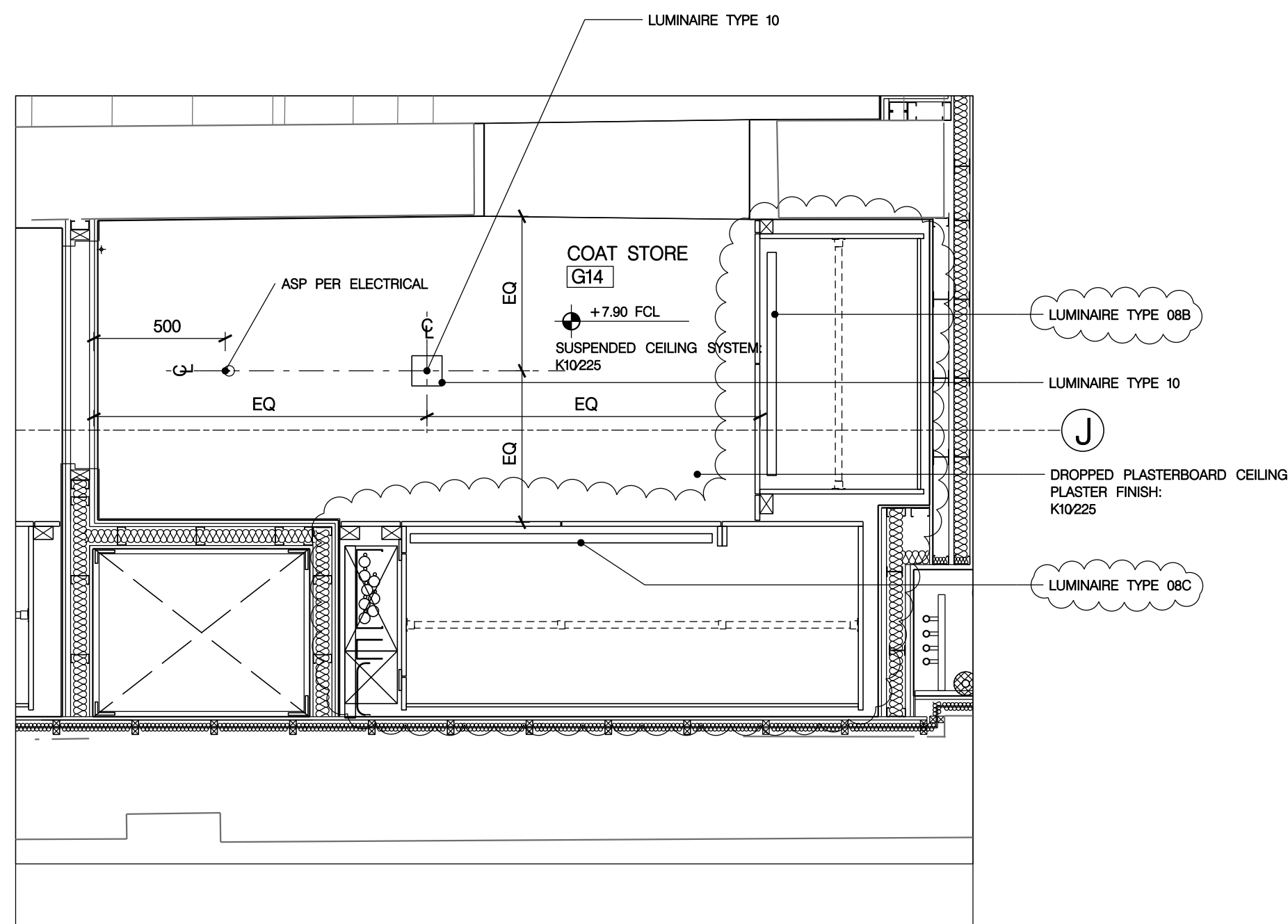

ROOM G14 - COAT STORE



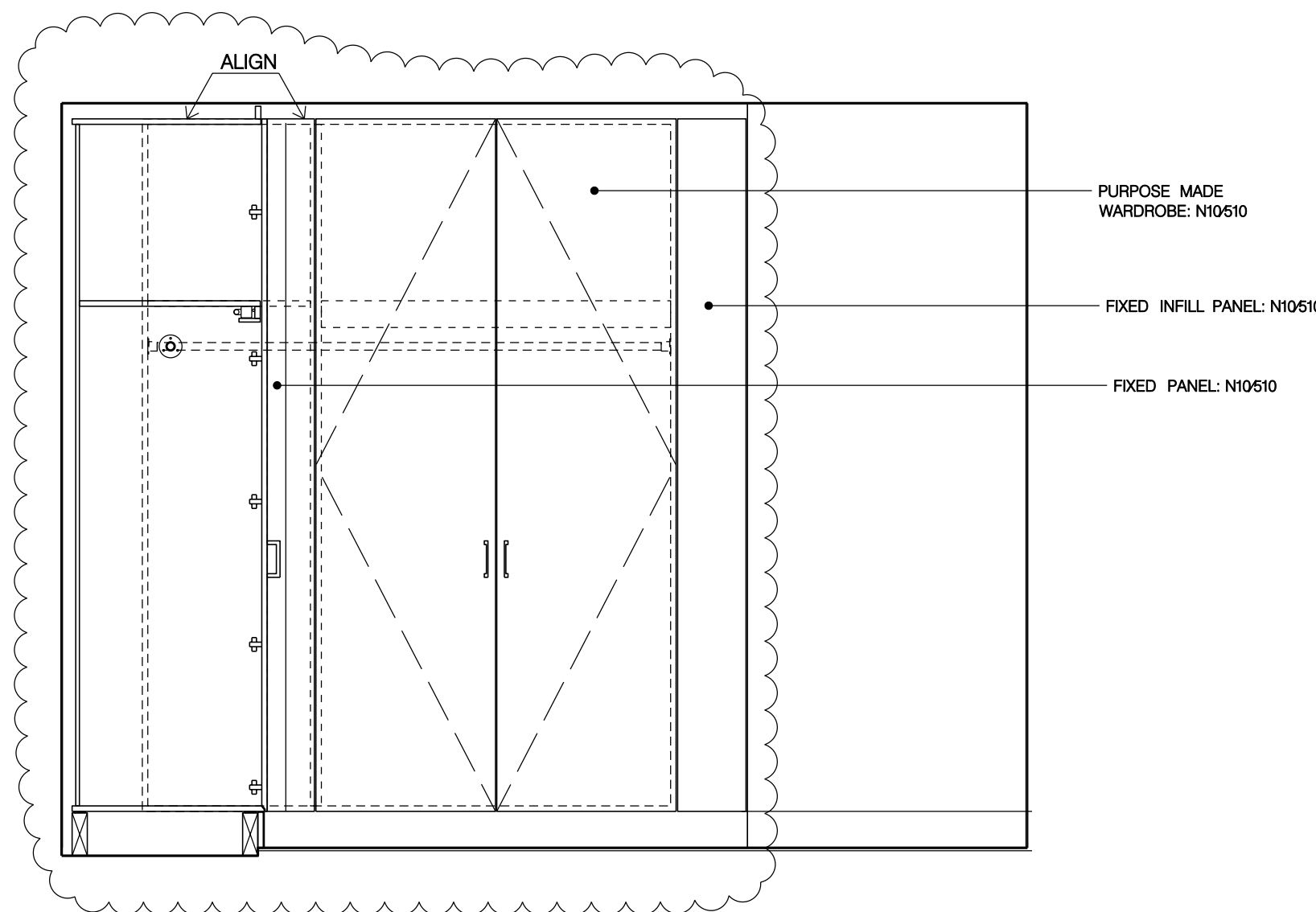

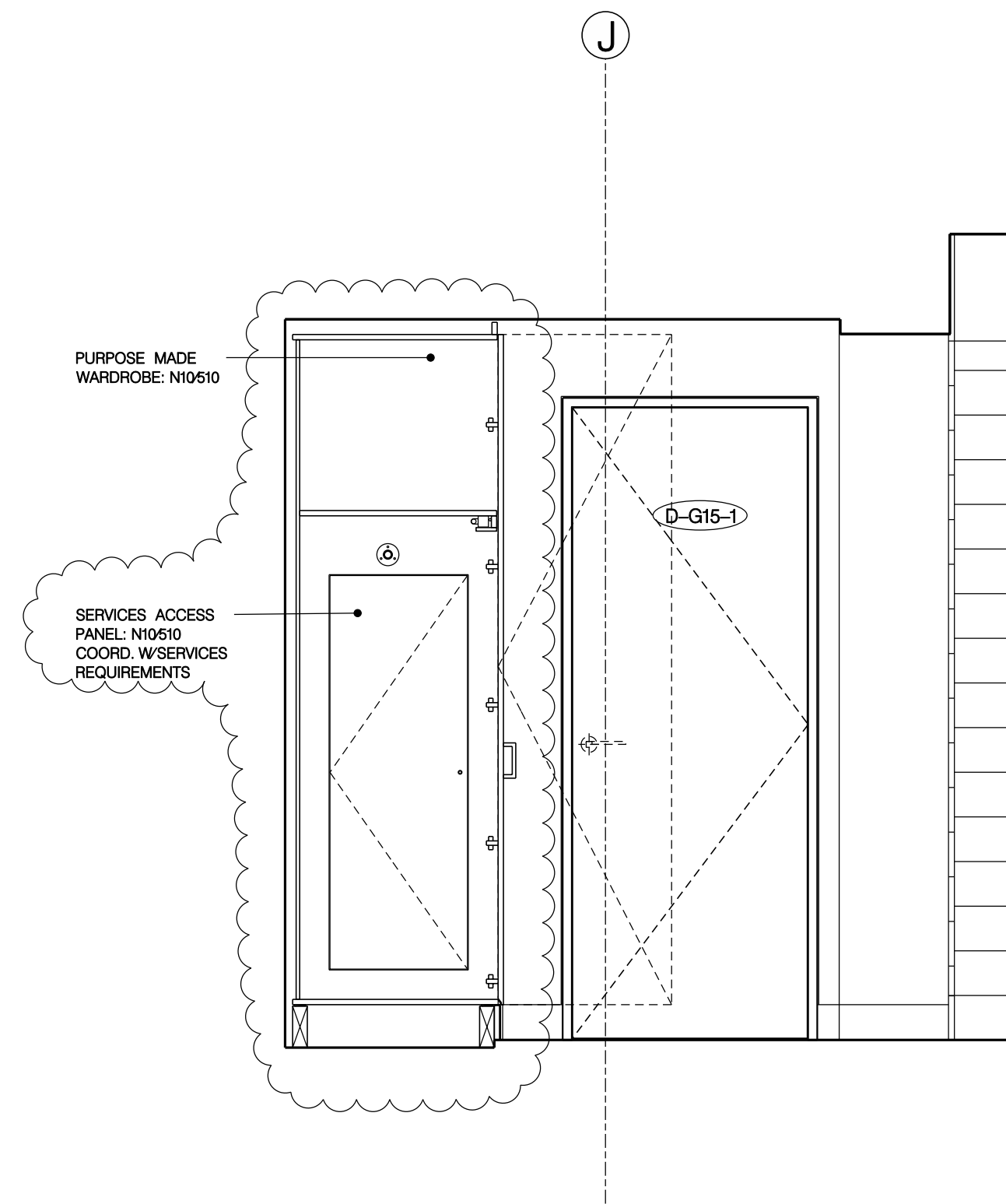

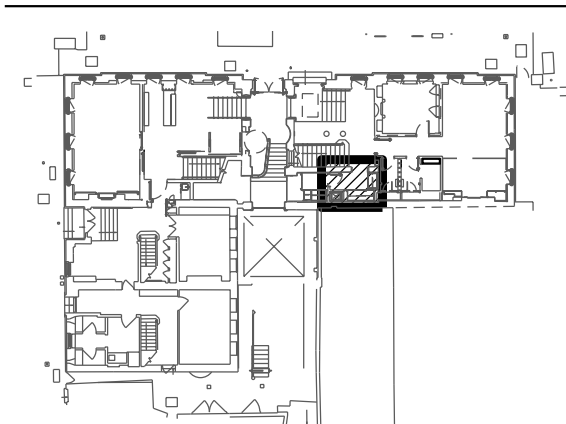
