### Contract for Services

If you are unhappy about this, please come and talk to me. It may be possible to take you on as an employee if that is what you want.


Please remember that by signing the contract you will be legally bound by its terms and conditions. Therefore I would stress that you should read it through thoroughly before you sign it.

When you are happy with it, please sign both copies and return them to me as soon as possible. I will then sign both copies and return one to you for your own records. If at any time you find that you have lost your copy and you would like another one, please do not hesitate to ask.

For Raphael Contracting to be able to pay you for your services you must submit a sales invoice to head office by 9am every Tuesday for payment into your account on the Friday. We recommend that you submit sales invoices in the format of the enclosed template. If your invoice is lacking any of the information as shown on the template it will be returned and it may therefore miss that week's payment run.

We would ask for you to let us have the above back as soon as possible.
