

APPENDIX A

HEAT-SOAKED GLASS: INCLUDED

Although not currently priced herein, Planet Contracting would recommend that some elements of glazing (particularly atria) would benefit from being of a 'heat soaked' specification to reduce the potential impact of Nickel Sulphide Inclusions (NiS). All toughened glass contains some level of impurity and one such impurity is Nickel Sulphide Inclusions (NiS). Most NiS inclusions are stable and cause no problems, however there is a potential risk that NiS inclusions could cause spontaneous breakage. By heat soaking toughened glass this risk is dramatically reduced although not completely eradicated

Planet Contracting would therefore recommend that heat-soaked glass is used for 'vulnerable' areas (and areas where if the panel were to fail at some point in the future it would be difficult to access for replacement) such as atria, high level glazing and balustrades. Although the heat soak test greatly reduces the risk of spontaneous breakage, it does not eliminate the risk entirely. Where heat soak testing has been requested / allowed for, toughened glass supplied by Planet Contracting is heat soak tested in accordance with BS EN 14179. Spontaneous fracture of toughened glass through NiS or any other inclusion whether heat soak tested or not is not covered under any warranty.

Please contact Planet for more information on NiS, heat soaking and associated cost advice if you feel this would be beneficial.

Planet's full Company Policy on Heat Soaking and NiS Spontaneous fracture is available on request.



ESTIMATE QUALIFICATIONS:

GENERAL NOTES

- Protection: we have provided an extra-over value for standard protection of the glazed installation using full coverage Correx sheet both sides. This would be carried out in one continuous visit and upon completion the works would be handed over to the main contractor. Any other works thereafter would need to be by others, including any repair or maintenance of the protection, removal and disposal of protection, and, final clean if required.
- 2) Fire & Acoustic Barriers:

We have made no allowance for the supply or installation of any Fire / Acoustic Barriers within the suspended ceiling voids or raised floor voids.

3) Works to Adjacent Structures:

We have made no allowance for any works to or above suspended ceiling or bulkheads / or below raised floor. Our head / floor / abutment tracks fix directly to ceiling grid / raised floor tiles / adjacent Drywall / blockwork and gain suitable stability from this construction. It is advisable however that timber grounds are built into adjacent Drywall / MF ceilings / bulkheads so as to gain a suitable fixing into these constructions.

- 4) We have allowed for PLANET's standard ironmongery.
- 5) Please be aware that our door systems would not be compliant with Secure by Design certification (PAS24).
- 6) Please note that we do not include finger guards as standard. Should anti-finger traps be required please advise us so that we can make an allowance accordingly.
- 7) We have excluded protection of our installed works.
- 8) We have excluded cleaning of our installed works.
- 9) We have made no allowance for any Access Control to our door-sets.
- 10) Please be aware that this installation will give rise to noise and dust. If the work is to be carried out in an occupied building, arrangements may need to be made by the contractor/client to protect the occupants. Should out of hours working be required, please notify us so that we can advise the additional costs.
- 11) Individual prices given are based upon the project proceeding in its entirety, should any element not be required; please advise us so that we can revise the price accordingly as some fixed overhead costs could alter the individual prices.
- 12) Structural openings into which we are to install our products must be true, level, square and accurate in size. The structure provided for us to fit to must be adequate to support and accommodate any imposed loadings of the installation and to guarantee fixings. Planet Contracting undertake engineering calculations only for their own structures and have made no allowance, and accept no responsibility, for engineer's calculations to any surrounding structure to which we are to fix, including any loads imposed on or transferred to the structure. It is the responsibility of the contractor/client to request such material information from Planet Contracting where needed for additional calculation purposes.
 - Planet Contracting accept no responsibility for checking the suitability, or accuracy of work carried out by others.
- 13) Opening/Closing forces for doors with self-closing mechanisms may not be compliant with Approved Document Part M (equality act) opening/closing forces. Therefore, the Design team/Client may need to consider additional options surrounding the operation of self-closing doors. Opening/Closing forces can be influenced by internal air pressures, air conditioning, heating etc. and can result in different opening/closing forces throughout the building. We cannot guarantee or predict the opening or closing forces that the doors will have when they are in their installed position.
- 14) Where relevant, the contractor/client is responsible for the cutting in and adaption of all floor finishes. Where floor spring boxes / lock keeps and any associated items are required these will be supplied free-issue for builders works to be undertaken by others.
 - Where floor-springs are to be set in a raised floor, we require the (free-issue) supply of 1No. raised floor
 pedestal per floor-spring for support. We have made no allowance for altering the raised floor other than
 to form hole in tile to fit floor spring (where floor spring position is on tile junction, any alterations to the
 floor involving moving pedestals, etc. are to be carried out by others).
 - Where floor-springs are to be set into a solid floor we require the floor-spring hole to be prepared by others (Planet will provide setting out / positioning instructions), we will install the floor-spring and set in position (making good to floor finishes (where required) to be by others).



- 15) No allowance has been made for the provision of samples, mock-ups or prototypes; or, for any laboratory or site testing of the installation.
- 16) All film manifestation to be applied to the outside face of the glass and to the floor side of Atrium glazing, i.e. not within the glazing cavity (to double-glazed systems) or void side of Atrium glazing, unless stated otherwise.
- 17) We have allowed for approval between Planet Contracting and the design team only. We have made no allowance for any costs associated with obtaining approval from local authorities etc.
- 18) Price subject to final design detail and all costs should be regarded as budget until a full site survey has been undertaken.
- 19) Our price does not include for any site attendance (post installation of our works) for maintenance during the warranty period or until practical completion of the project. If you require a maintenance plan for this period, please advise us so that we can incorporate your requirements and revise our estimate accordingly.
- 20) The above prices assume that the site access is suitable for this product both for the delivery of material and for the subsequent distribution of material to the working area.
- 21) We have made no allowance for any Mastic / Caulking / Filling within our price and assume these works will be carried out by the decorating sub-contractor.
- 22) The installation of our works (including any applied film manifestation if applicable) cannot commence in wet/dusty environments. The employing contractor must ensure site conditions are suitable to enable the installation of glass.

ATTENDANCES:

- Attendances are as detailed on the enclosed Appendix B "Details of Responsibilities". We reserve
 the right to review our estimate if these attendances are amended/altered.
- We have included for access to works up to 3 metres. Thereafter all access & fall protection scaffolding; adaptations; cradles; towers & working platforms suitable for the proper execution of our works are to be supplied, erected and dismantled by others unless noted separately.
 - Where glazing works are situated in an atrium location, and the glazing operation cannot be entirely carried out from the floor slab side, we would require a scaffold for our works. In this instance the scaffold should be able to accommodate vacuum lifting equipment. We would require a continuous ladder beam at the head of the scaffold, to enable the use of an electric winch to facilitate our works. A clear zone of 500mm from the outer face of the furthest protrusion would also be required. The scaffold should be able to accommodate all lifting operations and imposed loads.
- All works to be carried out during normal working hours. We have made no allowance for any out
 of hours working / deliveries.
- If applicable, Edge Protection would need to be provided by others; additionally, we have not allowed to remove any in situ edge protection prior to carrying out our works.
- Time lost by downtime or unavailability of tower cranes, hoists or goods lifts should be recorded and the equivalent period added to our sub-contract programme.
- Temporary Works: no allowance has been made for any temporary works.

AUTOMATICS NOTES

- 23) All electrical wiring, connections and conduit are to be by others.

This price is fixed for 1 month from date of quotation and due to volatility in raw material and supplier pricing (particularly aluminium and glass), we would therefore strongly recommend, where possible, that if the order can be placed within the fixed period, then it would be advisable to do so.
