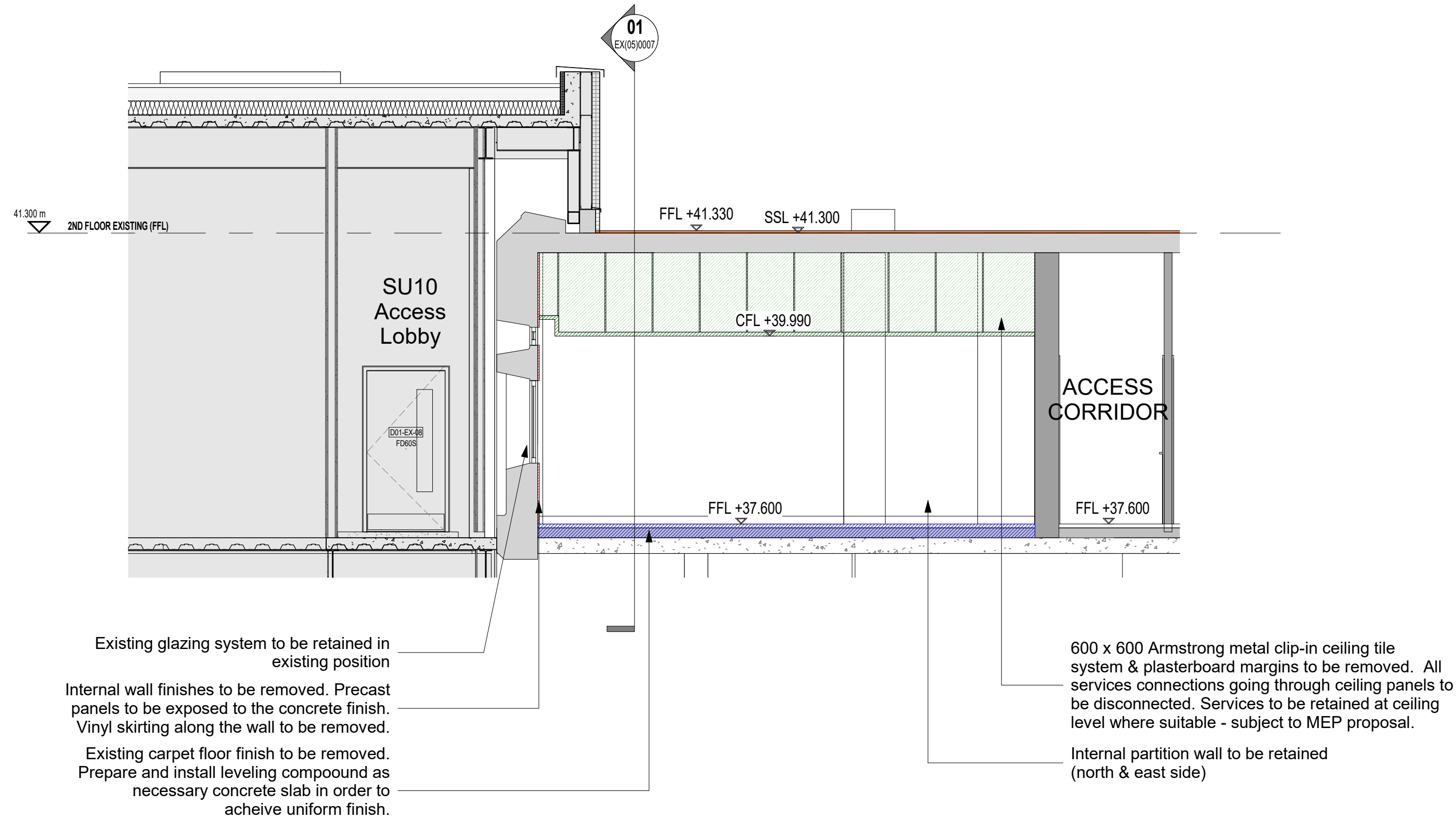

- Existing vinyl skirtings to be surveyed by sub-contractor on site and removed if not in good condition for future use.
- No hazard elements have been identified

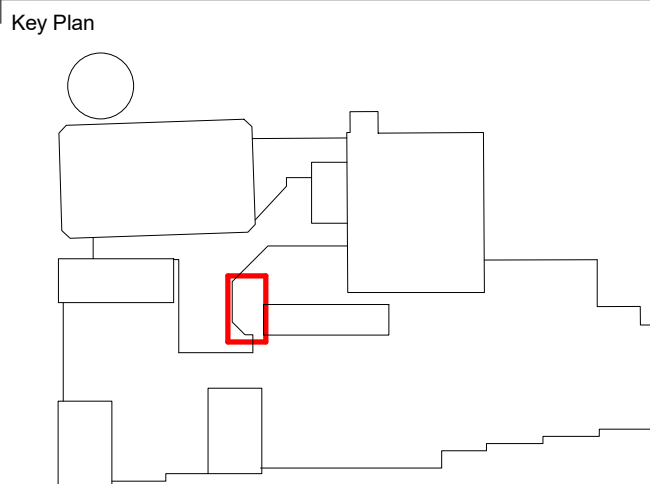
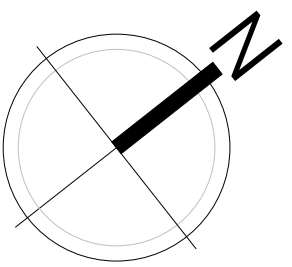

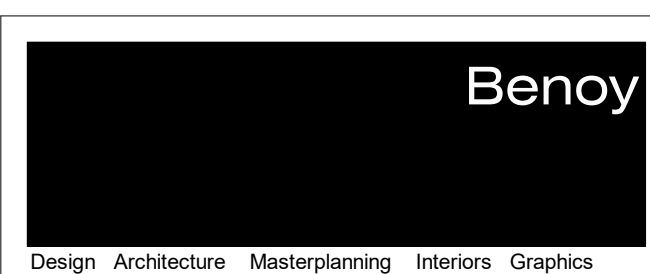
