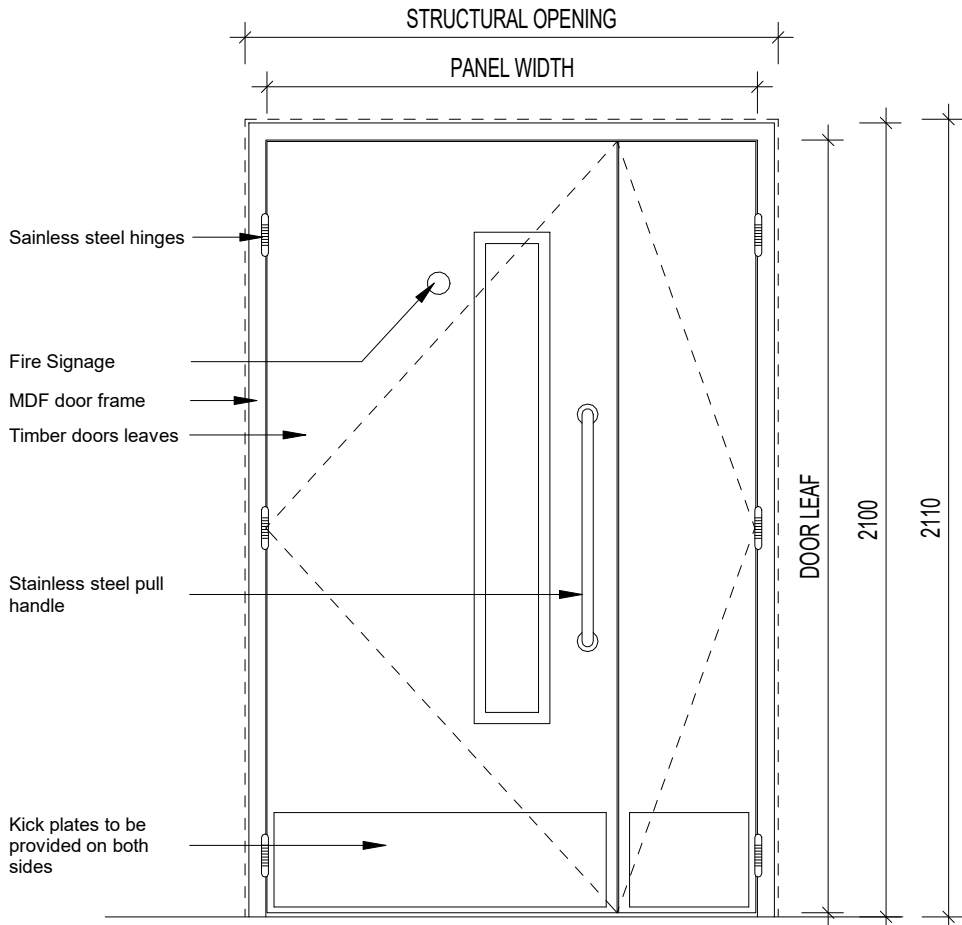

FRAME
30mm MDF H Section.

DOOR LEAF
Solid timber core material to suit 30min fire rating doorset. Door construction to be severe duty. Fire resisting smoke seal required specific to fire rating of door set. Doorset identification to be accredited by either BWF or TRADA "Q" Mark.

DOOR LIPPINGS
Edge Banded.

IDENTIFICATION
All doorsets to be supplied with tamper proof identification tag/sticker fixed to the inside jamb leaf bearing specification of the doorset including the fire rating of the door.

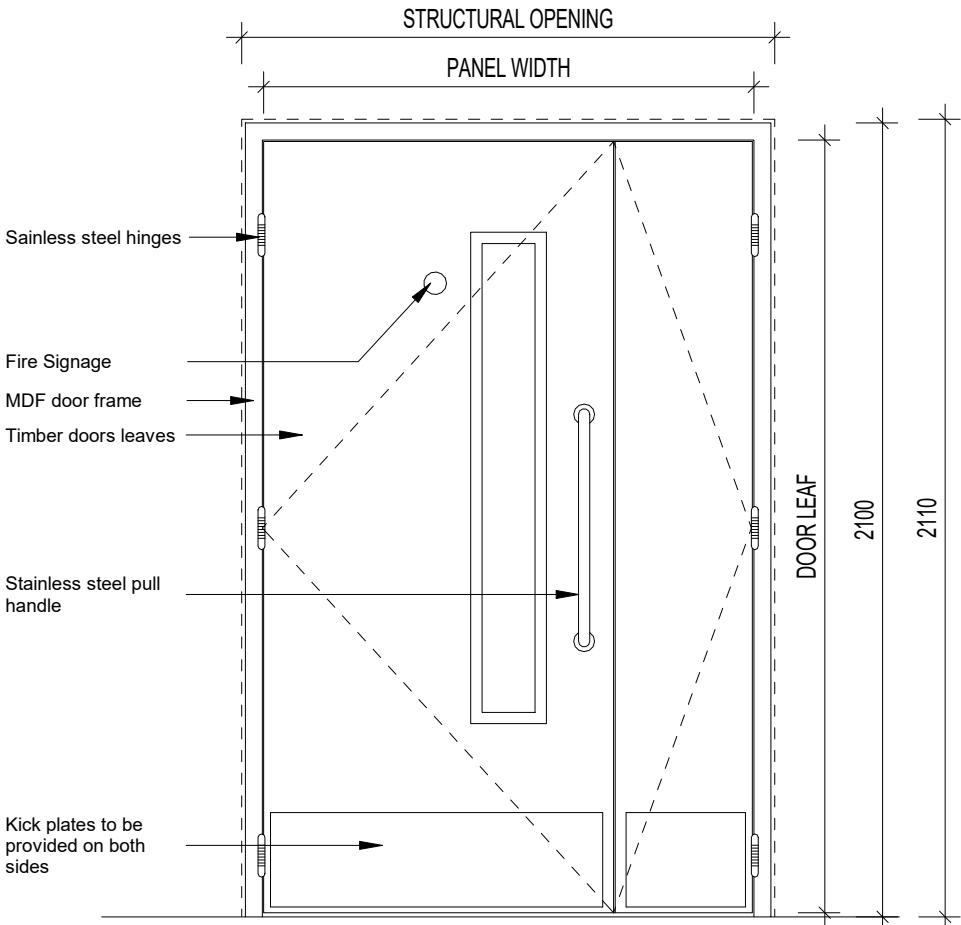

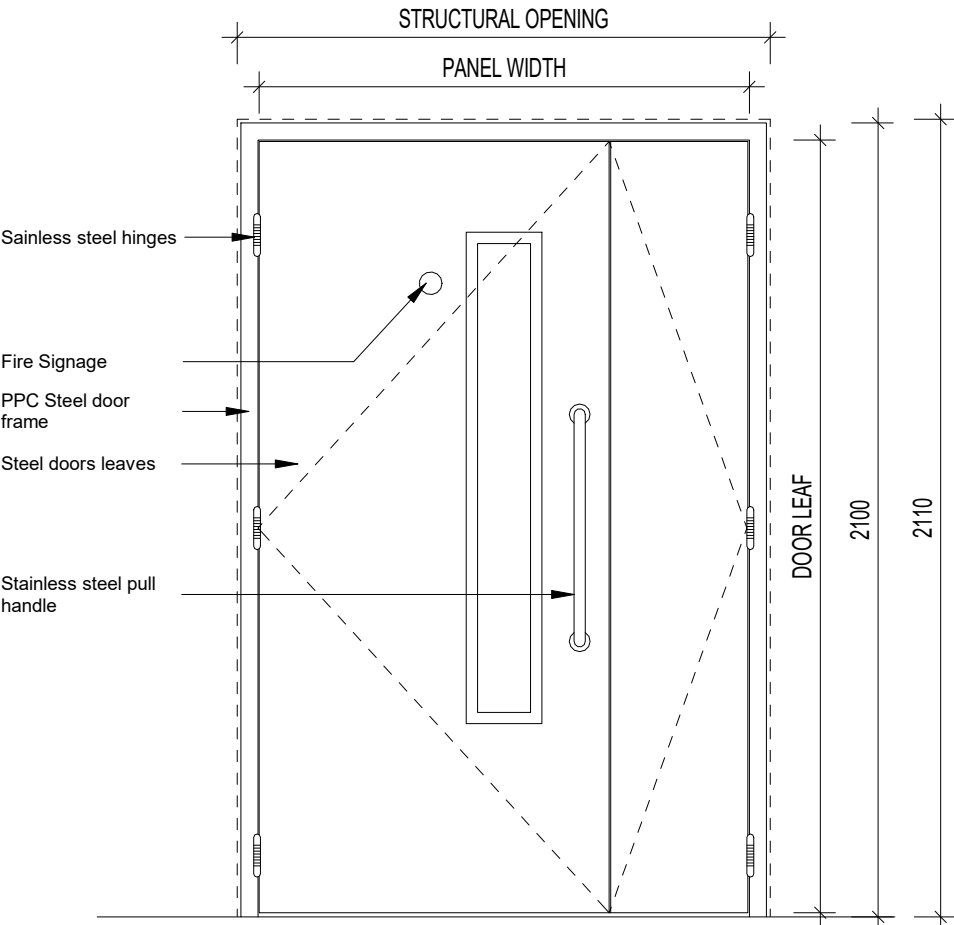

All doorsets to be supplied with tamper proof identification tag/sticker fixed to the inside jamb leaf bearing specification of the doorset including the fire rating of the door.
