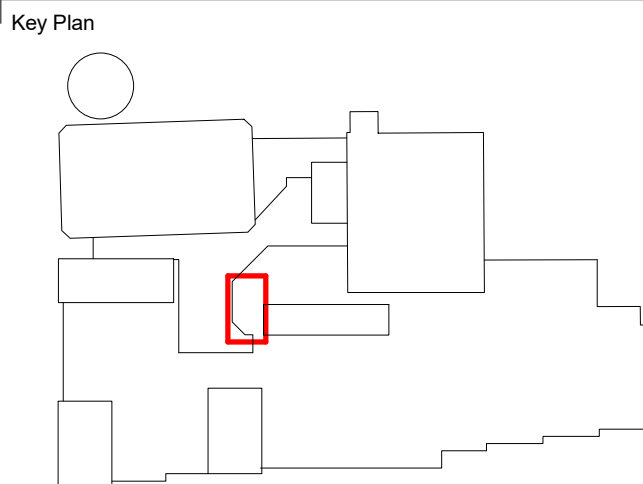
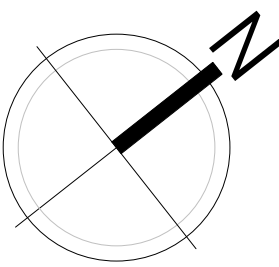
1 MA(20)0101 - Export House First Floor Plan - ACCESS STRATEGY
